This release is intended to discharge, in advance, McHenry County Bicycle Club, Inc., its successors and assigns, the promoters, the sponsors, the officials and any involved municipalities or other public entities (and their respective agents, officers, directors, employees, members, successors and assigns) from and against any liabilities arising out of or connected in any way with my participation in MCBC and its activities and events, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I further understand that serious accidents occasionally occur during bicycling, hiking, snowshoeing, cross-country skiing, camping, kayaking or other MCBC activities and events and that participants in such activities and events occasionally sustain mortal or serious personal injuries and/or property damage or loss as a consequence thereof. Knowing the risks of participating in bicycling, hiking, snowshoeing, cross-country skiing, camping, kayaking or other MCBC activities and events, I hereby agree to assume those risks and to release, indemnify and hold harmless all of the persons or entities mentioned above who might otherwise be liable to me for damages. It is further understood that this waiver, release and assumption of risk is binding on my heirs and assigns.
